

## **PAINT PROTECTION FILM (PPF)**

### **TEN (10) YEAR LIMITED WARRANTY – TERMS & LIMITATIONS**

#### **1. Warranty Duration**

Unless otherwise expressly stated in writing, the Paint Protection Film (PPF) installed on the vehicle is covered by a Ten (10) Year Limited Warranty, effective from the original installation date. Any deviation from this warranty term must be clearly documented in writing on the original invoice, work order, or warranty registration. Verbal statements do not modify this warranty.

#### **2. Warranty Coverage**

This Ten (10) Year Limited Warranty covers the Paint Protection Film installed on the vehicle, including both the material and its installation, subject to the terms, exclusions, and limitations stated herein. Coverage applies exclusively to Paint Protection Film installed by the installer and only to the specific panels and coverage areas documented at the time of installation. No warranties, express or implied, are provided beyond those stated in this document.

#### **3. Covered Defects**

During the ten-year warranty period, the installer warrants that the installed Paint Protection Film will remain free from defects that materially affect its performance or integrity under normal use and proper care, including yellowing, cracking, bubbling, delamination, and adhesion failure not caused by external impact, contamination, misuse, or improper care. If a covered defect occurs, the installer will, at its sole discretion, repair or replace the affected area.

#### **4. Scope of Responsibility**

All warranty evaluation, determination, and service are administered exclusively by the installer. The installer's determination regarding warranty eligibility is final.

#### **5. Cosmetic Standards & Expectations**

Paint Protection Film conforms to the surface beneath it. Existing paint defects may remain visible. Minor seams, edges, relief cuts, and pattern boundaries are normal and unavoidable. Absolute invisibility is not guaranteed. Cosmetic preferences do not constitute a warranty defect.

#### **6. Exclusions**

This warranty does not cover damage from impacts, road debris, accidents, misuse, improper washing, chemical exposure, normal wear, third-party alterations, or failure to follow care instructions.

#### **7. Owner Responsibilities**

The vehicle owner must follow all care and maintenance instructions and present the vehicle for inspection if requested.

#### **8. Inspection & Claims**

Warranty claims must be submitted before any repair or modification and the vehicle must be presented clean and accessible.

#### **9. Remedy**

The installer may repair or replace the affected area at its discretion.

#### **10. Limitation of Liability**

This warranty does not cover any costs beyond repair or replacement of the affected Paint Protection Film. Maximum liability shall never exceed the original amount paid.

#### **11. Transferability**

This warranty is non-transferable unless stated otherwise in writing.

#### **12. Dealer Installations**

Coverage applies only to documented areas regardless of dealership representations.

#### **13. Governing Law**

This warranty is governed by the laws of the state where installation occurred.

#### **14. Acceptance**

By accepting the vehicle or registering the installation, the customer agrees to these terms.
